Efforts to run into trouble in World War II,

The World Health Organization has been involved in this process from the very beginning.

The World Health Organization was formed in 1948. and is a special agency of the United Nations. The WHO emblem shows the snake Moses wrapped around a wheel, symbol of the "all-seeing eye", on the image is a flat earth surrounded by two ears of wheat, symbol of harvest Harvest and 9 people.

In each ear of wheat there are 13 elements, a symbol of the 13 "Tribes of Israel". These are 13 Illuminati families.

At the 63rd meeting of the World Health Assembly, prepared by the secretariat and the World Health Organization, voluntary donations for 2008-2009 are selectively reported.

According to this report, the US government received 424.5 million US dollars and the Bill and Melinda Gates Foundation - 338.7 million US dollars.

Donors in the "Global Alliance for Vaccination and Immunization" GAVI with 85 million US dollars is the Gates Foundation. The Gates Foundation has donated more than 1.14 billion US dollars from 1999 to 2009. . While the US government donated only 569 million US dollars for the years 2001-2009.

For 30 years, human rights organizations and various other such activists have accused UNICEF and the World Health Organization of a planned campaign to sterilize the population in various countries using vaccines for various diseases.

For example, in 1993 a scientist at the Innsbruck "Institute for Biometric Research" of the Austrian Academy of Sciences and scientists and the World Health Organization are developing birth control vaccines.

2004 Nigeria boycotts vaccine manufactured precisely for sterilization

The vaccine contains estradiol, a form of the hormone estrogen.

This hormone leads to infertility.

1992 The World Health Organization excludes "homosexuality" from the list of diseases, giving real reasons and grounds for the proliferation of genderism.

The Catholic organization "Mexican Committee for Life" organized protests.

The World Health Organization is given rights not only to make recommendations, but also, as usual, to demand and issue orders to countries.

On September 12, 2019, the Global Vaccination Summit was held in Brussels. The main organizers were the World Health Organization and the European Commission.

**. TAKING DAYS, RNA TECHNOLOGY, NANOTECHNOLOGIES :** Everyone will be connected to the 5G network with supercomputers that will control and manage it. In this way, there will be continuous control over his personality and life. The chip will transmit all personal data. With tweaks, the nanoparticles will be able to attach to molecules from other coronaviruses. The nanoparticles are 25 nanometers and are so small that once injected, they pass through the intercellular lattice of the skin and make their way to the lymph nodes. Within minutes, they reach a concentration thousands of times greater than in the skin. The nanoparticles in these vaccines can be directed to move quickly in the desired direction and force the human's biological cells to move and grow in certain ways. directions. Back in 2009 scientists from the University of London have developed "micro shuttles" that can be injected during vaccination and deliver drugs to living cells. A microscopic chip should be embedded in these nanoparticles to automatically control the dose of medication. The separation of substances can also be separated by an external command - from a doctor or another, i.e. individual micro-therapy is created. The biggest advantage of using such micro capsules is that they are developed to be very stable in the human body, which protects their contents. These capsules can be used as repositories of medicines in the body for later use. Whoever manages technology will actually manage human health. That is different drugs can be released for specific cells. That is nanoparticles in vaccines can multiply their effects, either enhance or devastate a person's immunity. Digital human identification has been considered since September 11, 2001. digital identification of the person by embedding in the person's body an electronic microchip.

On March 12, 2020, INOVIO Pharmaceuticals announced that it has received a new \$5 million grant from the Bill & Melinda Gates Foundation to accelerate testing and manufacture of its proprietary CELLECTRA 3PSP smart device for intradermal/subcutaneous delivery of INO-4800 – DDDNNNK vaccine for COVID-19.

That is this proves that the vaccine was ready even before the pandemic. That is even before the "state of emergency" was declared in the western countries in connection with the pandemic, additional funding was announced for the special device that is needed to deliver this vaccine into the human body. **PROCEDURES**

WHO Member States agree to Executive Board Resolution 150(3) (2022) and World Health Assembly Resolution WHA75(9) (2022) and begin a process to amend the current International Health Regulations (2005) (IHR).

This is happening in parallel with the process of negotiations for the preparation of a pandemic instrument.

The negotiations on the pandemic instrument and the process are led by the WHO member states.

Here, the relevant Ministry of Health is responsible for each country.

The negotiations talk about the following main terms as follows in the period 22-26 April 2024.

- "early warning signal"
- ∓ This signal is given by the Director-General of WHO alone to all Member States. That is the procedure is activated upon a signal sent by a single person.
- ∓ "event". It is an indication of the manifestation of a disease or a circumstance that creates the potential for disease. Whether there is an actual manifestation of disease is not discussed here.
- "sick person" means an individual suffering from or affected by a physical illness that may pose a risk to public health. It all depends on the free interpretation of the WHO Director-General.
- "National IHR Authority" means the entity designated or established by the State at the national level to coordinate the implementation of these Regulations within its territory. This means that this administration will be specialized and will be created at the request and initiatives of the WHO.
- "National IHR Focal Point" means the national center designated by each country that will be available for communications with WHO IHR Contact Points under these Regulations. The connection will be directly with the WHO, without any national mediation.

The powers of the WHO, who prove the withdrawal of health sovereignty, national sovereignty, the confidants of national security, and politicians sovereignty, national sovereignty, public sovereignty, sovereign guaranteeing human rights and freedoms

✚ The WHO Director-General has the following powers, which GUARANTEE UNIFORM MANAGEMENT OF ALL PROCEDURES AND DIRECTIVES AND AGREEMENTS WHICH ARE BINDING FOR EACH COUNTRY

✚ determine for the Member States in whose territory the event occurs whether it constitutes an emergency or a pandemic in accordance with the criteria and procedure set out in the new health rules

✚ If the Director General of the WHO and the Member States do not reach a consensus within 48 hours whether the event constitutes an emergency, the procedure under Art. 49 shall be applied. to the dissenting state.

✚ This includes convening the Emergency Committee and making binding recommendations to the dissenting state

✚ This includes convening the Emergency Committee and making binding recommendations to the dissenting state

✚ If the Director-General of the WHO determines that there is an international public health emergency in the country or countries concerned, including a pandemic, the WHO, under the order of the Director-



General, can mobilize international assistance on the ground - i.e. international forces and forces from other countries subordinated to the Director-General of the WHO DIRECTLY.

At the same time, the Member State must respond to such a proposal as soon as possible, including the reasons for the response.

THIS PROVES that the WHO can enter the respective country without its consent and do whatever it wants in that country.

THIS IS STATE CAPTURE WITHOUT ANY SANCTIONS WITHOUT REQUIRING THE CONSENT OF THE RELEVANT STATE.

- Pursuant to Article 12, the WHO Director-General issues temporary recommendations based on Article 49, which may be amended or extended. These recommendations may be issued with additional temporary recommendations after the end of the pandemic. IE AT THE DISCRETION OF THE DIRECTOR GENERAL WHO CAN DO WHATEVER HE WANT IN THE RELEVANT COUNTRY OR THE RELEVANT COUNTRIES IGNORING ANY SOVEREIGNTY OF THAT COUNTRY, IGNORING THE CONSTITUTIONS, LAWS OF THE RELEVANT COUNTRIES.

The national authorities of the respective countries are waiting for the Secretary-General of the WHO to determine all actions and for him to determine whether the pandemic has passed or not. He is the one who decides this, no institution from the respective country.

THIS AND REAL DICTATORSHIP and UNCONDITIONAL DICTATORSHIP and UNCONDITIONAL DICTATORSHIP.

- The measures, which are imposed according to the procedure under Art. 49, cannot be canceled earlier than 3 months after their announcement. MEANWHILE, THE DIRECTOR-GENERAL AND WHO REALLY RULE EVERYONE AND EVERYTHING IN ONE COUNTRY WITHOUT ANY EXPLANATION, IN VIOLATION OF ANY STATE LAWS, CONSTITUTION.

During this time, the ghetto party dipectop of the WHO CAN ANNOUNCE QUARANTINES, LOCKDOWNS, all kinds of masks, tests, restrictions, the issuance of the certificate, EVEN VACCINATION - FORCED.

- ✚ Along with the "standard measures", WHICH INCLUDES ALL RESTRICTIONS - MOSTLY FORCING ones.

The Director-General of the WHO has the authority to impose restrictions, in the presence of two specific criteria in emergency situations.

- ✚ Then they can be used by the Director-General of the WHO and other international organizations and bodies, at his DISCRETION, EVEN MILITARY BODIES and OTHERS to ENFORCE the MEASURES and ACTIONS ORDERED by the DIRECTOR-GENERAL.

In accordance with Article 12, the Director General shall assess the availability and accessibility of health products necessary to respond to a public emergency.

That is THIS MEANS THAT THE DIRECTOR-GENERAL PERSONALLY DETERMINES THE TREATMENT, MEASURES, IMPACT AND ENFORCEMENT OF VACCINATIONV

WHO's surveillance and control of ports, airports, entrances and exits, as well as certificates and investigations of compliance with their certification procedures, are being strengthened.

That is THIS MEANS THAT ALL NATIONAL SOVEREIGNTY ARE ATTACKED - MORSA, BORDER, NATIONAL SECURITY, AIR SOVEREIGNTY, NATIONAL SOVEREIGNTY, POLITICAL SOVEREIGNTY.

ANY ACTIONS AND REACTIONS BY GOVERNMENTS, national services, national police, military of the respective country are EXCLUDED. That is ANY OTHER NATIONAL BODIES AND ORGANIZATIONS MAY BE USED by the WHO Director-General, including NATO troops.

Each country must develop, strengthen and maintain, no later than five years after the entry into force of these Regulations, which are BINDING ON EVERY COUNTRY, the basic capabilities for detection, assessment, notification and reporting to WHO

WHO collects and evaluates this information, without INTERESTED IN THE ASSESSMENT OF THE CORRESPONDING COUNTRY.

INDIVIDUAL STATES ARE OBLIGED TO PROVIDE THIS INFORMATION every 24 hours after notification to the WHO.

Any consultations between the state and the WHO are IN CLOSED, SECRET.

If the relevant member state does not accept the proposal for cooperation that the WHO REQUIRES, the WHO MAY HAVE THE RIGHT to share with other member states the information it has. WHO ENCOURAGES AND ACTUALLY COMPELS THE MEMBER STATE IN RELEVANCE TO ACCEPT WHO'S OFFER FOR PARTNERSHIP AND ITS STATE GOVERNANCE. Realistically, if a country does not agree with the WHO, WHO can FORCE NEIGHBORING COUNTRIES TO CLOSE BORDERS - AIR, LAND, SEA with the respective country and in this way FORCE IT TO ACCEPT THE INSTRUCTIONS and FOLLOW WHO'S ORDERS.

In addition to the standard measures of disinfection, deratization and disinsection by a "given country" it may also require information on the complete itinerary of passengers, baggage or shipments, as well as a non-invasive medical examination of a "suspicious passenger".

The regulation is MANDATORY.

Point 14. Passengers who must be vaccinated or offered prophylactic treatment in accordance with these Regulations, or their parents or legal guardians, must be informed of any risk associated with vaccination or the use of preventive treatment and of the risk of disease and non-vaccination or use of preventive treatment.

That is EACH PASSENGER IS OBLIGED TO UNDERGO THE MEASURES INDICATED in point 14 - vaccination and others. THIS IS FORCED DICTATION

This applies to EVERY PASSENGER, even if he is not a patient.

EACH PASSENGER WILL NOT REALLY HAVE ANY RIGHTS OF CHOICE.

EVERY TRAVELER AWAY FROM HIS HOMELAND IS ACTUALLY FORCED TO BE VACCINATED IN ORDER TO BE ABLE TO RETURN HOME.

That is THERE ARE NOT AND CAN'T BE ANY RUDE PASSENGERS HERE,

That is WHO ASSUMES THE OBLIGATION TO IGNORE THE COUNTRY RELEVANT AND IMPOSE MEASURES AND ACTIONS ON TRAVELERS WHATEVER IT WISHES.

MEASURES FOR VEHICLES ARE EVEN HARDER.

EVERY PASSENGER TRAVELING WITH APPROPRIATE RELATIVES, actually and his RELATIVES COME UNDER THE ACTIONS AND MEASURES OF WHO.

MASTERING NATIONAL SOVEREIGNTY and all types of SOVEREIGNTY

Art. 42 stipulates that the measures implemented by the states must be in accordance with national legislation.

CONTEMPORARY Art. 43 requires that NATIONAL LEGISLATION SHOULD COMPLY WITH INTERNATIONAL NORMS related to public health.

That is THE NATIONAL LEGISLATION IS IGNORED BEFORE THE REGULATORY INTERNATIONAL ACTS OF A SUPRANATIONAL ORGANIZATION SUCH AS WHO.

AT THE SAME TIME, THE SOVEREIGNTY OF PERSONAL DATA, personal information,

According to point 2 of Article 42, it is permissible in theory, but not in practice, for a country to apply only its own national measures, but if it dares to behave in this way, point 6 gives it a period of 3 months to rethink its actions and at least finally comply with WHO criteria and recommendations.

Both personal and health data in accordance with Art. 45 with which a person is identified were confidential, THEREFORE THEY MAY BE PROCESSED and DISCLOSED when necessary at the request of WHO.

- The cooperation provides for reporting to the WHO on the measures taken by the states.
- According to Art. 45, personal and health data, which refer to an identified or identifiable person, were confidential, but.....regardless of this, they could be processed and disclosed when necessary for the purposes of the assessment and public health risk management, and of course - at the request of the WHO.
- Who prepares a list of experts for MOH? Who appoints one member from each country to intergovernmental and regional integration organizations? Who establishes the Emergency Committee? Who appoints the consultants to the Emergency Committee? Only one answer - the Director General of the WHO. You can see how, by sending their proposal for membership in these bodies, the countries themselves put the officials in the WHO as mediators of the dictatorship. And then they declare to us that they did not fulfill the will of the WHO. Yes, they are right because they left the will at the disposal of the official sent to the WHO, whose job it is to comply with the statute and its policy. He stops working for the country whose representative he is. Therefore, it is unnecessary to ask who are our delegates to WHO. Whatever they are - THEY ARE NO LONGER OURS.

- The first report of the results of the new MHR will be submitted to the WHO WHO after the 1st and before the end of the 5th year of the entry into force of the new MHR.
- There is also a Committee for the Implementation and Compliance of the International Health Regulations to "encourage" (i.e. pressure) their application and monitor the compliance of other international regulations with these rules (i.e. a legal-administrative laboratory for correction of inconsistent legislation). Let's see the response of our people's representatives, who beat their chests that they will introduce laws to improve our living standards and our economy, when they have to vote on changes and revisions to national legislation and international treaties, and even concessions that do not correspond to the MoH . Art. 57 gives the right to states to interpret as they wish all other international regulations and agreements, as long as they do not contradict the International Criminal Code (ie the highest law may be neither the Constitution nor national or international legislation , and WHO rules). It's not even about enforcing laws, it's about interpreting them. We may have very good laws, but if they contradict the MHP they will have to go to mandatory interpretation. We have already seen how the constitution and laws are interpreted when they contradict the European regulations, so when the deputies swear to observe them - we must interpret their oath according to the interpretation in terms of contradiction of the noems.

Disputes between individual countries under the new IHR are intended to be referred to the Director-General of WHO or to the Permanent Court of International Arbitration, and disputes between WHO and individual/states to the World Health Assembly.

**VACCINATION CERTIFICATES** : Article 36 gives a green light signal to holders of vaccination certificates, even if they show signs of the disease, but also empowers the competent authority to which the certificate is presented to refuse the passenger to proceed if that control authority has access to verifiable indications and evidence that vaccination was ineffective. If the WHO body shows, but does not prove, that the vaccination WAS INEFFECTIVE, it should impose vaccination actions.

The "efficiency" criterion is deliberately not commented upon.

By COMPLETE CONTROL and MANAGEMENT of carrier certification, control is also given to trade and the entire economic process between countries, WHO CAN TRADE, WHY, and WHO CANNOT.

Each carrier will be required to complete "health declarations" and certificates of sanitary condition of the vehicles valid for 6 months.

According to Art. 40, point 2, health fees may be imposed on passengers

Any person can be treated or quarantined for a fee or vaccinated for free.

It is possible to QUARANTINE AVAILABLE on a given person.

Under the pretext of a "false positive", a person MAY BE FORCED QUARANTINED - ie. THE INCONVENIENT PERSONALITY.

#### **AMENDMENTS TO INTERNATIONAL DOCUMENTS**

- With the new MZP, some international regulations in force until now are also amended:

- (a) International Sanitary Convention, signed at Paris on June 21, 1926;
- (b) International Sanitary Convention for Air Navigation, signed at The Hague on 12 April 1933;
- (c) International Agreement for the Abolition of Health Certificates, signed at Paris on December 22, 1934;
- (d) International Agreement for the Abolition of Consular Visas for Health Certificates, signed at Paris on December 22, 1934;
- (e) Convention amending the International Sanitary Convention of June 21, 1926, signed at Paris on October 31, 1938;
- (f) International Sanitary Convention of 1944, amending the International Sanitary Convention of June 21, 1926, opened for signature at Washington on December 15, 1944;
- (g) International Sanitary Convention for Air Navigation, 1944, amending the International Sanitary Convention of April 12, 1933, opened for signature at Washington on December 15, 1944;
- (h) Protocol of 23 April 1946 extending the International Sanitary Convention of 1944, signed at Washington;
- (i) Protocol of 23 April 1946 extending the International Sanitary Convention for Air Navigation, 1944, signed at Washington;
- (j) the International Sanitary Regulations of 1951 and the Supplementary Regulations of 1955, 1956, 1960, 1963 and 1965; and
- (k) The International Health Regulations of 1969 and their amendments of 1973 and 1981.

**ENTRY INTO FORCE, REJECTION AND RESERVATIONS** Art. 59 and Art. 61

- The Amendments are scheduled to enter into force on 31 May 2024.

This should be done at the table of the World Health Assembly of the World Health Organization from 27.05.2024 to 01.06.2024.

Within 18 months of the entry into force of the International Health Regulations, countries can reject the rules or make reservations. After this period, nothing will be possible.

- If a country is unable to fully adjust its domestic legislative and administrative arrangements with the IHR within 18 months, it must do so in an additional 12 months after the first 18 and if it has notified the Director General that it requests an additional period.

So, between 27.05 and 01.06.24, the development of progress in the arrangements for these amendments to the existing 2005 International Health Regulations will be reported. Formally, their difference with the pandemic instrument is that they may not be legally binding, but for this purpose political will is required and representation in the structures of the WHO that is truly committed to our rights, to oppose within the given time limits. And it is best not to have any involvement in this specialized UN agency at all. It not only gives us the straitjackets, but also leads us to new debts and responsibilities.
